

Cayucos Citizens Advisory Council December 6, 2017

Meeting called to order in the Vets Hall Tent by President John Carsel - 7:00PM
approx. 25 in public attendance.

Minutes :

Co. Public Works - Dave Flynn

Dave Flynn: Public Works is working closely with Central Services. There is progress with the Vet's Hall. We have meetings coming up with State Parks regarding historical documents and one with the steering committee.

Yama Mohabat: Last month Mike Britton was here about 4 way stops. We are going to propose two more 4 way stop signs at Ocean Avenue and Cayucos Drive that will be over sized along with "stop ahead" signs. If there are concerns, we will consider alternatives.

Greg Bettencourt: It was my understanding that the justification for the additional stop signs was anticipated problems.

Yama Mohabat: There are studies showing the need.

Bruce Gibson: Both. There is an ordinance that was not acted on.

Greg Bettencourt: Do we want 4 way stop signs at Cayucos Dr. and Ocean Ave.? Can we have some kind of vote fo consensus?

John Carsel: We could put this on for next month's agenda.

Dave Flynn: Some things are discretionary. When we are looking at warrants, given a certain number of pedestrians and vehicles, it is more of a standard of practice that we need to follow. We want to accommodate the community but we have to meet the health and safety guidelines.

Lynn Schoenauer: Not every state gives pedestrians the right of way.

Francie Farinet: I drive that every day and I don't know that a stop sign is necessary.

Gil Igleheart: What if we tried to slow down the traffic first.

John Carsel: A show of hands please. How many do not want to see this on the agenda next month? The majority do not support having this item on the agenda.

The Toro Creek bridge over Hwy 1 is in the budget for 2021. That will put bike lanes on the Toro Creek bridge.
